

Application Criteria for In-Home Learning Support Grant

Information for Applicants

Please read this section **BEFORE** sending in your application to the Ngāti Mutunga o Wharekauri Iwi Trust ('the Trust').

Type of grant available

The Trust will provide In-Home Learning Support Grants for all students on Wharekauri and Rangiauria, due to Covid-19 disruptions to in-school learning. The grant will be a **one-off** \$600 contribution towards the home internet usage bill to offset the costs incurred from at home learning during the 12-week period of nation-wide lockdown level 3 &4.

Conditions of application

All of the following conditions must be met before an In-Home Learning Support Grant is considered by the Trust:

1. The student who was learning from home is the applicant.
2. The applicant is a registered beneficiary of the Trust.
3. The student is enrolled in a primary, secondary or tertiary education institute.
4. The student was a resident of Wharekauri or Rangiauria during the nationwide 12 week lockdown.
5. If the applicant is under the age of 18 the application must also be completed and signed by the applicant's parents or caregiver (unless there are extenuating circumstances).
6. Each application must be accompanied by the following written confirmation:
 - a. Proof of enrolment in an education institute as at March 2020.
 - b. Proof of internet connection as at April 2020 by way of an invoice from the internet provider.
7. Each applicant is entitled to apply for one grant per household.
8. By applying for an In-Home Learning Support Grant, the applicant (and the parent/guardian if necessary) acknowledges that the information provided may be disclosed to members of the Trust and any third parties the Trust considers necessary to confirm the accuracy of the application (such as the relevant school). This includes liaising directly with third parties.
9. Consideration and approval of applications is in the sole and unfettered discretion of the Trust. Submitting an application which meets all valid conditions does not guarantee approval.
10. If accepted, the In-Home Learning Support Grant will be deposited into the household internet service payers account, with the applicant being notified that payment has been made.
11. **The funding round will close 12pm Friday 13th November 2020.**
