Information for Applicants

Please read this section **BEFORE** sending in your application to the Ngāti Mutunga o Wharekauri Iwi Trust (The Trust).

TYPE OF GRANT AVAILABLE

The Ngati Mutunga o Wharekauri lwi Trust focus is to enhance educational outcomes for our tauira in tertiary training / education. This grant will be a contribution towards supporting enrolment fees for students of Ngati Mutunga o Wharekauri descent.

CONDITIONS OF APPLICATION

All of the following conditions must be met before a Tertiary Grant application is considered by the Trust.

- 1. The student who is attending a tertiary institute is the applicant.
- 2. The application must be signed by both the applicant and the applicant's parent or caregiver if the applicant is under 18 years of age. (unless there are extenuating circumstances)
- 3. The applicant must be of Ngāti Mutunga o Wharekauri descent.
- 4. At least one parent of the applicant must be a registered member of Ngāti Mutunga o Wharekauri Iwi Trust (application forms are available from the Trust's office or online at www.nmow.co.nz).
- 5. Each application must be accompanied by confirmation of the applicant's bank account and written confirmation from the Tertiary Provider that the applicant attends.
- 6. Each applicant is entitled to apply for one Tertiary Grant per financial year (for the avoidance of doubt, successive applications in one year are permitted if the previous application was declined).
- 7. Consideration and approval of applications is in the sole and unfettered discretion of the Trust. Submitting an application which meets all valid conditions does not guarantee approval.
- 8. By applying for a Tertiary Grant, the applicant acknowledges that the information provided may be disclosed to members of the Trust, and the names of recipients of the Tertiary Grant may be included in the Annual Report.
- 9. The 2022 funding round will close at 5pm CI Time on 5pm on Tuesday, 28 February 2023.
- **10.** If accepted, the Tertiary Grant will be direct credited to the applicants account.
